**Tournament Rules & Regulations**

1. Participants must be residents of Lancaster County, **or** a be a member of, **or** maintain a handicap at a club located in Lancaster County, with an official USGA index of 36.0 or less based on at least 10 scores.
2. Field will be limited to 60 teams. All others will be placed on the alternate list in the order applications are received. Play will be Alternate Shot. Each partner tees off, and then each hits the other partner's tee shot. From there, one ball is chosen to be played through the hole with partners alternating shots.
3. If one partner who has entered as part of a team cannot play due to extenuating circumstances, a substitute may play in his/her place providing the committee is notified of the substitute's name and handicap.
4. Flights will be determined by number of entrants. The handicap index of the team will be used to place teams in flights. Handicaps will be determined by adding the two indices, and dividing that number by two.
5. Prizes will be awarded for overall champion, and gross and net scores in each flight. In case of a tie, the champion will be determined by a sudden death playoff.
6. No outside advice is permitted. Outside advice is defined as from anyone other than your partner or your caddy.
7. Players may carry their own bag, or ride a cart. Caddies are permitted, but must be 14 years or older. Only two (2) carts are available for use in any one group.
8. USGA Rules govern all play. Spectators must stay in the rough.
9. Entry fee includes cart fee and is not refundable. This fee **does not** include a practice round.
10. Play will be a shotgun start at 1:00 p.m. Check Lancaster newspapers, LLCCGA website at [www.lancasterladiesgolf.com](http://www.lancasterladiesgolf.com), or call Crossgates Pro Shop (872-4500) for starting hole and flight information.
